

## **ON-SCREEN ADVERTISING**

### WHY ADVERTISE IN MOVIE THEATERS?

#### **Engaging Environment**

Movie theaters offer a unique, distraction-free environment, complete with huge screens and immersive sound systems. Your ad will be showcased in an ideal atmosphere in front of an audience who is comfortable and attentive. Moviegoers spend an average of 14 minutes in their seats before a movie starts. They are relaxed, receptive, and captivated, ensuring you will have their full attention. Movie going is the #1 leisure activity for Americans. The Melba Theater appeals to a wide range of ages.

# WHAT SHOULD I CONSIDER WHEN DESIGNING MY SLIDE?

A simple and concise message is the key to an effective cinema advertising campaign. Your main idea should be focused on a single product or unit selling point. Avoid using white as a main background color. A dark background contrasted with light text will draw much more attention and will result in a more appealing look.

All content must be for general audience viewing. Copyright and trademark restrictions must be respected.

#### Format and sizing

Final ads may be submitted for print via e-mail or on standard storage media.

Dimensions: 1280 x 720 // Color Mode: RGB File Format: All supplied ads must be compatible with either Adobe Photoshop or Illustrator. .psd, .ai, .eps, .tif, .jpg, .pdf are all preferred formats.

#### **Design Proof**

Once your advertising materials have been submitted, you will receive a design proof of your new ad(s) via email. Your design will not be submitted until you have had the opportunity to look over your design, request any changes, and approve the final layout.

#### **Pricing**

Advertising rates are a per month basis on length of contract with a suggested 12-month reservation.

- Month-to-month advertising: January-November = \$200 per month December\* = \$300 per month. Annualized cost for choosing month-to-month advertising: \$2,500.
- 6-Month Advertising Agreement: \$1,050/ \$175 per month, unless December\* is included in the 6 months. If December is included in the 6 months: \$1,170 / \$195 per month. Annualized cost for staying on a 6-month agreement: \$2,220 (saves \$280)
- -12-Month Advertising Agreement: \$1,800 / \$150 per month (saves \$700 ) includes the "Very Melba Christmas" movie series.
- \*Advertising for the month of December is \$300 and includes our "Very Melba Christmas" movie series with additional promotions.

#### **Payments**

Advertisers who do not pay for their total agreement up front will be invoiced monthly. Payments must be received before advertisements will show. Payment is due on the 15th of the month for the upcoming month. Payments can be made with cash, check or card. Payments can be mailed to 115 West Main Street, Batesvillle, AR 72501 or online at melbatheater.org

#### Visibility

The advertisers slide(s) will be shown at least 10 times in the rotation before each show. Each slide will show for 7 seconds.

#### How do I order graphic design?

Professional ad design is provided through the Melba Theater. Photos, logo, text, and contact information for your design may be submitted via e-mail or on standard storage media. The email address is mandi@melbatheater.org Please include your company logo and contact information, as well as any special promotion or sale you would like your ad to focus on. Be sure to include any photos of employees, products, or your storefront that you would like to feature.

#### **Ad Options**

Your advertising can consist of a combination of up to three different layouts. Some advertisers prefer to use one design for multiple showings, ensuring repetitive recognition. Some advertisers opt to advertise more than one service or product, choosing a variety of three separate designs.
